

Official Rules for WROC-TV & WUHF-TV  
RBTL Stars of Tomorrow Competition

1. How it Works: Participating students of Rochester Broadway Theatre League's 2011 Stars of Tomorrow have already been selected and were announced at a ceremony held at the Auditorium Theatre on May 5, 2011. These students are the only eligible contestants. Voting for the public's choice of "favorite lead male or female high school performer" begins at 12:00 p.m. EST Wednesday May 11, 2011 and ends at 12:00 p.m. EST, Wednesday, May 25, 2011. The results of the online vote play no role in deciding which two students go on to the next round of Stars of Tomorrow's NYC Bound national competition. 2. How to vote: Go to [www.rochesterhomepage.net](http://www.rochesterhomepage.net) and click Community, then Contests, then RBTL Stars of Tomorrow. Watch videos, read bios, see photos, have fun! Voting is limited to one vote per day per person per IP address. If any manipulation, tampering, or other irregularities in voting are detected or otherwise believed to be going on, WROC-TV and WUHF-TV reserve the right to choose a winner by using the runner-up method, or by forming a panel to choose one, if necessary.
3. Selection of winner: Chances of winning depend entirely on number of votes received. Note that winner and other contestants may be videotaped for broadcast. All prize winners may be required to sign an affidavit of eligibility, advertising and liability release within 1 day of notification or prize will be forfeited. Winners may be asked to provide an official photo ID (New York State License, Official State ID, or Military ID) to verify age and residency. Verification could take up to one hour as identification is verified, waiver/agreement forms are signed and winners may be videotaped for broadcast. If the winner is asked to and declines to provide adequate verification, then he or she forfeits winning and another random drawing will be held to determine a winner. Judges' decisions are final.
